ORDINANCE NO. 19-11-04-42

AN ORDINANCE PURSUANT TO TITLE EIGHT, CHAPTER ONE, SECTION THREE OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2006, WATER TAPS

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY", have determined that it is necessary and beneficial for the citizens of the City of Le Roy to have reasonable and flexible access for water inspections, and

WHEREAS, the cost and expense of providing water inspections after City of LeRoy business hours and on weekends exceeds the inspection fee schedule currently in place; and

WHEREAS, the Mayor and City Council of the City of Le Roy have previously adopted an ordinance providing for the inspection of water projects at a rate of \$50 per inspection; and

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, in lawful meeting assembled on Monday, November 18, 2019, as follows:

That Title 8, Chapter 1, Section 3, Subsection F, Municipal Code of the City of Le Roy, Illinois, 2006, is hereby amended by adding the following language in **bold** and removing the following language in strikethrough:

F. Inspections: No connection shall be covered until the work has been properly inspected by a city official or other individual designated by the city. A fifty dollar (\$50.00) inspection fee will be assessed for each required inspection during regular City business hours (7:00am-4:00pm, Monday-Friday). If an inspection is requested outside of regular City business hours or on the weekend (Saturday and Sunday), a one hundred dollar (\$100.00) inspection fee will be assessed for each required inspection. If the work completed does not pass inspection and must be re-inspected, an additional twenty-five (\$25.00) fee will be assessed.

This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
