

A RESOLUTION OF ADOPTION OF THE MCLEAN COUNTY MULTI-JURISDICTIONAL ALL HAZARDS MITIGATION PLAN BY THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS

WHEREAS, the City of Le Roy is subject to natural and man-made hazards including severe thunderstorms, severe winter storms, floods, tornadoes, and drought among others, that pose risks to public health and property; and

WHEREAS, the City of Le Roy desires to prepare and mitigate for such natural and man-made hazards; and

WHEREAS, under the Disaster Mitigation Act of 2000, the United States Federal Emergency Management Agency (FEMA) requires that local jurisdictions have in place a FEMA-approved Hazard Mitigation Plan as a condition of receipt of certain future Federal mitigation funding after November 1, 2004; and

WHEREAS, the McLean County Multi-Jurisdictional All Hazards Mitigation Plan was developed in accordance with the regulations of the Disaster Mitigation Act of 2000 and the guidance provided by FEMA; and

WHEREAS, the City of Le Roy has participated in developing the McLean County Multi-Jurisdictional All Hazards Mitigation Plan covering member jurisdictions of McLean County:

NOW THEREFORE, be it resolved that the City of Le Roy hereby:

1. Adopts the McLean County Multi-Jurisdictional All Hazards Mitigation Plan as the official Hazard Mitigation Plan of City of Le Roy; and
2. Agrees to participate in the annual and 5-year updates to this Plan.
