


#### Receipt

## ORDINANCE NO. 15-11-04-10

ORDINANCE ABATING THE TAX HERETO LEVIED FOR THE YEAR 2015 (PAYABLE 2016) TO PAY THE PRINCIPAL OF AND INTEREST ON \$3,600,000 GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE), SERIES 2007, OF THE CITY OF LE ROY, MCLEAN COUNTY, ILLINOIS.

# ANNUAL ABATEMENT ORDINANCE

WHEREAS, the City Council (the "City Council") of the City of Le Roy, McLean County, Illinois, an Illinois Municipal Corporation, (the "CITY"), by Ordinance Number 07-05-03-10, adopted on the 21<sup>st</sup> day of May, 2007 and by Ordinance Number 07-09-01-20, adopted on the 4<sup>th</sup> day of September, 2007 (the "Ordinance") did provide for the issue of \$3,600,000 on the 4<sup>th</sup> day of September, 2007 (the "Ordinance") did provide for the issue of \$3,600,000 on the 4<sup>th</sup> day of September, 2007 (the "Bonds"), and the levy General Obligation Bonds (Alternate Revenue Source), Series 2007 (the "Bonds"), and the levy of a direct annual tax sufficient to pay the principal of and interest on the Bonds; and

WHEREAS, it has been determined that the Pledged Revenues (as defined in the Ordinance) will provide an amount not less than 1.25 times debt service of all Outstanding Bonds (as defined in the Ordinance) in the next succeeding bond year (June 1 and December 1); and

WHEREAS, it is necessary and in the best interests of the City that the tax heretofore levied for the year 2015 (payable 2016) to pay the principal of and interest on the Bonds be abated;

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, McLean County, Illinois, in lawful meeting assembled, as follows:

- Section 1. Abatement of Tax. The tax heretofore levied for the year 2015 in the Ordinance is hereby abated in its entirety.
- Section 2. Filing of Ordinance. Forthwith upon the adoption of this ordinance, the City Clerk shall file a certified copy hereof with The County of McLean, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the year 2015 (payable 2016) in accordance with the provisions hereof.
- Section 3. Effective Date. This ordinance shall be in full force and effect forthwith upon its passage by the City council and signing and approval by the Mayor.

SECTION 2. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
