ORDINANCE NO. 22-12-04-40

AN ORDINANCE AMENDING TITLE FOUR, PUBLIC HEALTH AND SAFETY, CHAPTER 2, GARBAGE AND REFUSE; SECTION 2, REFUSE COLLECTION AND DISPOSAL, SUBSECTION 4, RATES; OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 2003 (as amended)

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is necessary and in the best interest of the City and its residents that the rates for refuse collection services be amended with said amendments to be effective January 1, 2023 within Title Four, Public Health and Safety, Chapter 2, Garbage and Refuse; Section 2, Refuse Collection and Disposal, Subsection 4, Rates; of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended)

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Le Roy, in lawful meeting assembled, on Monday, December 19, 2022, as follows:

Section 1. That Section Title Four, Public Health and Safety; Chapter 2, Garbage and Refuse; Section 2, Refuse Collection and Disposal, Subsection 4, Rates; Part (A) Rates Established; Number 2, Schedule of Rates; of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), are hereby deleted.

Section 2. That Section Title Four, Public Health and Safety, Chapter 2, Garbage and Refuse; Section 2, Refuse Collection and Disposal, Subsection 4, Rates; Part (A) Rates Established; Number 2, Schedule of Rates; of the Municipal Code of the City of Le Roy, Illinois, 2003 (as amended), are hereby adopted in words and figures as follows:

Section 3. Title 4 – Public Health and Safety, Chapter 2 – Garbage and Refuse, shall be amended with revisions in bold lettering.

§ 4-2-2-4 Rates.

- A. Rates Established: Refuse rates for a calendar month for each classification of refuse collection customers shall be as follows:
1. Multifamily Dwellings: Multifamily dwellings, being a residential building, complex of residential buildings, or a mobile home park, containing two or more separate dwelling units, shall be billed per unit even if one or more dumpsters are used for the convenience of the landlord, tenants, or both.

2. Schedule of Rates:

3. **Service Fee:** All refuse collection customers will be required to pay a service fee of \$7 per month beginning with the first bill payable in January, 2023.
4. **Adjustment of Rates:** Effective November 1, 2023, refuse rates will be evaluated and adjusted annually to reflect any changes within the refuse collection providers contract. Any adjustment will be made effective with the first billing cycle after November 1, 2023

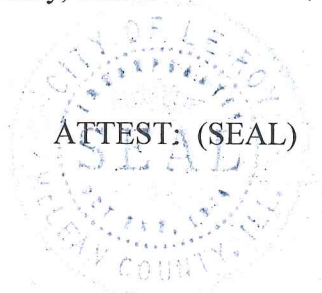
