ORDINANCE NO. 23-03-02-50

**AN ORDINANCE INCREASING THE NUMBER
OF CLASS A LIQUOR LICENSES**

WHEREAS, the City of Le Roy has authority, pursuant to the Illinois Liquor Code, to regulate the use, consumption and sale of alcoholic liquor within the corporate limits of the City of Le Roy; and

WHEREAS, the City of Le Roy has enacted a comprehensive Liquor Code incorporated as Chapter 3-3 of the City of Le Roy Code of Ordinances; and

WHEREAS, the City of Le Roy currently limits the number of Class A liquor licenses to no more than four licenses within the corporate limits; and

WHEREAS, it is in the best interests of the health, safety and welfare of the citizens of Le Roy to increase the number of Class A liquor licenses from four to six due to an increased demand for said licenses within the corporate limits.

NOW, THEREFORE, be it ordained by the City Council for the City of Le Roy, McLean County, Illinois, as follows:

Section 1. That Section 3-3-12 of the City of Le Roy Code of Ordinances be and the same is hereby amended to read as follows, with strikeouts indicating deletion in text and underscore indicating addition to text:

Section 3-3-12. Only ~~four~~six Class A licenses may be issued and outstanding at any one time in the City. All other classes of licenses are not restricted as to number that may be issued.

Section 2. Publication. The City Clerk be and is hereby authorized and directed to publish this Ordinance in pamphlet form as provided by law.

Section 3. Severability. In the event any part of this Ordinance shall be found and determined to be invalid by a Court of competent jurisdiction, all valid parts that are severable from this invalid part shall remain in full force and effect.

Section 4. Repealer. All ordinances or parts of ordinances in conflict herein, are hereby repealed, provided, however, that nothing herein contained shall affect any rights, action, or causes of action, which have accrued to the City of Le Roy, prior to the effective date of this Ordinance.

Section 5. Effective Date. This Ordinance shall be in full force and effect ten (10) days following its publication in pamphlet form as provided by law.



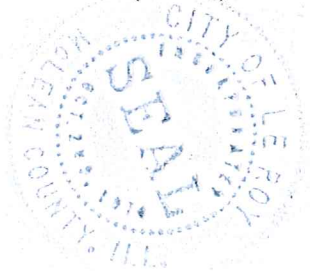

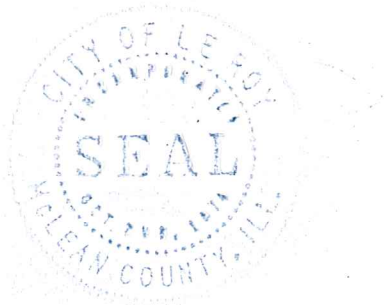
