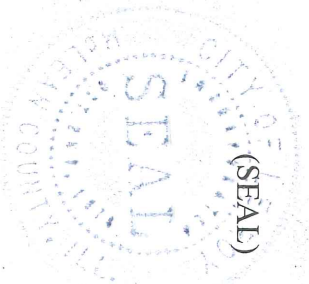

**AN ORDINANCE DESIGNATING AND RENAMING PERSIMMON DRIVE TO SOUTH
PERSIMMON DRIVE**

WHEREAS, the City of Le Roy is an Illinois municipal corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and

WHEREAS, Section 11-80-19 of the Illinois Municipal Code grants the corporate authorities the power to change the name of any street, avenue, alley or other public place; and

WHEREAS, the City has determined that the street commonly known as "Persimmon Drive," as more fully depicted on the plat attached hereto as **Exhibit A**, should be renamed as "South Persimmon Drive."

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:

Section 1. Recitals. The City Council hereby incorporates the recitals set forth above into this Ordinance by this reference.

Section 2. Renaming; Notice. The City Council hereby renames the street commonly known as "Persimmon Drive," as depicted on the plat attached as Exhibit A and as legally described in Exhibit B, as "South Persimmon Drive." The City Clerk is hereby directed to send a copy of this Ordinance by certified mail, return receipt requested, to the McLean County Clerk and the United State Post Office for Le Roy, Illinois (61752), as required by 65 ILCS 5/11-80-19.

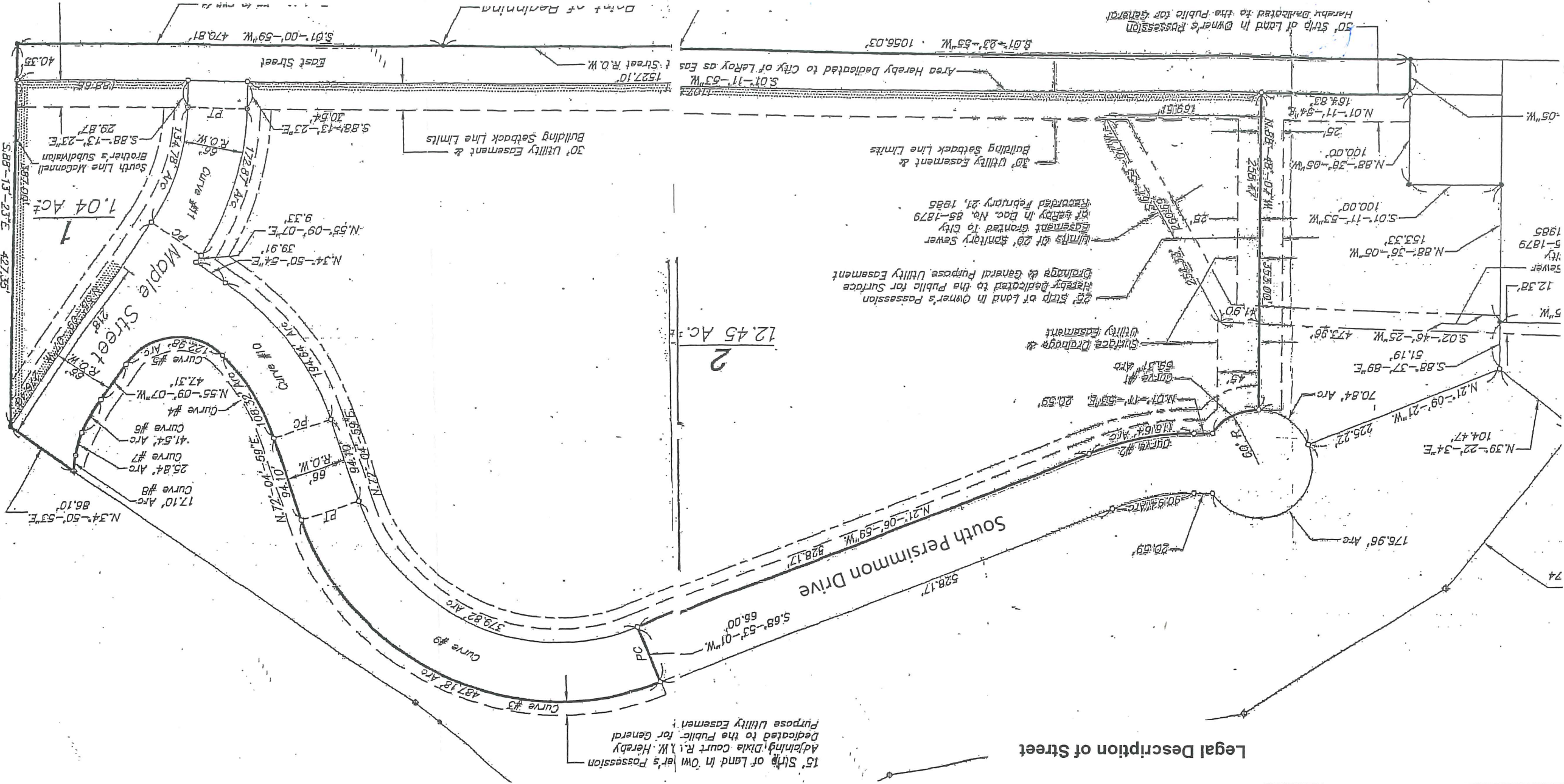
Section 4. Conflict. All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section 5. Effective Date. This Ordinance shall be in full force and effect 30 days after a copy of this Ordinance has been sent to the McLean County Clerk and the United States Post Office for Le Roy, Illinois (61752), as designated by the certified mail return receipt.





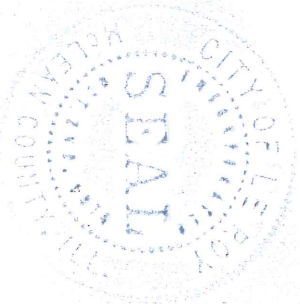
