ORDINANCE NO. 23-04-06-80

AN ORDINANCE AUTHORIZING THE TRANSFER OF PROPERTY 111 EAST CENTER STREET, LE ROY, ILLINOIS

WHEREAS, the Local Government Transfer Act (50 ILCS 605, *et seq.*), authorizes the transfer of property from a municipality, including a township, to another municipality, all as set forth in the Act; and

WHEREAS, Empire Township currently owns the property identified as Parcel No. 30-21-309-007, common address 111 East Center Street, Le Roy, Illinois; and

WHEREAS, Empire Township no longer has a need for said property and will be benefitted by the transfer of said property to the City of Le Roy; and

WHEREAS, the City of Le Roy is willing to accept the transfer of the property described herein from Empire Township to the City of Le Roy; and

WHEREAS, it is in the best interests of the health, safety and welfare of the citizens of Le Roy to authorize and accept the transfer of property described herein to the City of Le Roy.

NOW, THEREFORE, be it ordained by the City Council for the City of Le Roy, McLean County, Illinois, as follows:

Section 1. That the City of Le Roy does hereby declare it necessary or convenient for it to use, occupy or improve and own the real estate described as Parcel No. 30-21-309-007 with a common address of 111 East Center Street, Le Roy, Illinois.

Section 2. That the City of Le Roy does hereby authorize the Mayor to accept a transfer of the property described above from Empire Township to the City of Le Roy in exchange for the payment of One Dollar (\$1.00).

- Section 3. That the Mayor be and he is hereby authorized to take any and all action necessary and execute any and all documents for and on behalf of the City of Le Roy, in order to effect the transfer of the property described herein from Empire Township to the City of Le Roy.
- **Section 4.** Recitals. The foregoing Recitals are incorporated herein and form a part of this Ordinance.
- **Section 5. Publication.** The City Clerk be and is hereby authorized and directed to publish this Ordinance in pamphlet form as provided by law.
- **Section 6.** <u>Severability.</u> In the event any part of this Ordinance shall be found and determined to be invalid by a Court of competent jurisdiction, all valid parts that are severable from this invalid part shall remain in full force and effect.
- **Section 7.** Repealer. All ordinances or parts of ordinances in conflict herein, are hereby repealed, provided, however, that nothing herein contained shall affect any rights, action, or causes of action, which have accrued to the City of Le Roy, prior to the effective date of this Ordinance.
- **Section 8. Effective Date.** This Ordinance shall be in full force and effect ten (10) days following its publication in pamphlet form as provided by law.
