# AN ORDINANCE APPROVING A VARIATION OF ACCESSORY BUILDING SQUARE FOOTAGE REQUIREMENTS OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 2003 TITLE 10-ZONING

WHEREAS, a petition to permit a variation for the real estate described hereinafter was received by the City of Le Roy, in regard to premises described hereinafter, said petition seeking a variance in accessory building square footage requirements within the R-1, 1 & 2 Family Residential district, from the 950 square feet maximum to a total of 956 square feet and from a maximum roof height of 15 feet to a total roof height of 19 feet and 3 inches as measured as the average roof height between the top wall plate and the ridge of the gable roof, and from the limit of a one-story detached structure, to a detached two-story structure to allow for the construction of a detached garage on Lot 20, 21 & 22 in Block 22 in the Moorehouse and Barleys Addition to the City of Le Roy, and the South half of the vacated alley lying North & adjacent in the City of Le Roy, McLean County, Illinois; and

(commonly referred to as: 808 E.Pine Street)

**WHEREAS**, a public hearing was held by the Zoning Board of Appeals of the City of Le Roy, Illinois, on May 4, at 7:15 p.m. at the City Hall, Le Roy, Illinois, in accordance with the laws of the State of Illinois and the ordinances of the City of Le Roy, McLean County, Illinois, to consider said petition, after due notice was given in accordance with all applicable laws and ordinances; and

**WHEREAS**, said Zoning Board of Appeals did recommend to the City Council of the City of Le Roy, Illinois, to approve said petition for a variation in square footage, roof height requirements and number of stories; and

WHEREAS, all things required by law and ordinance to be done in regard to the variation of the zoning regulations regarding the hereinafter described property have been completed,

**NOW, THEREFORE, BE IT ORDAINED,** by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

#### **Section 1.** The real estate described as follows:

Lots 20, 21 & 22 BLK 22 Mooehouse & Barleys Addn & S ½ Vacated Alley LYG & ADJ within the City of Le Roy, McLean County, Illinois

(Commonly referred to as: 808 E. Pine Street)

Is hereby granted a variation from the City of Le Roy Municipal Code maximum square footage requirement of 950 square feet in accessory building square footage to a total of

956, and a variation from the City of Le Roy Municipal Code maximum roof height of 15 feet to a total roof height of 19 feet and 3 inches as measured from the average height between the top wall plate and the ridge of the gable roof, and from the limit of a one story detached structure to a two-story detached structure to allow for the construction of a detached garage at the referenced property.

<u>Section 2.</u> This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
