RESOLUTION NO. 97-7 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LEROY, ILLINOIS, CONSENTING TO THE SALE AND ASSIGNMENT OF ASSETS, INCLUDING THE CABLE TELEVISION FRANCHISE, FROM CABLE TV FUND 14-A, LTD. TO TRIAX MIDWEST ASSOCIATES, L.P.

WHEREAS, on September 4, 1990, the City Council of the City of LeRoy, Illinois ("Grantor") granted to Cable TV Fund 14-A, Ltd. ("Seller") a franchise as set forth in Ordinance No. 376, to own and operate a cable television system in the City of LeRoy (the "Franchise"); and

WHEREAS, Triax Midwest Associates, L.P., a Missouri limited partnership ("Buyer") has entered into an Asset Purchase Agreement with Seller (the "Agreement"), whereby Buyer will purchase and acquire from Seller the Franchise and Seller's real and personal property used or held for use in connection with the Franchise (the "System"); and

WHEREAS, Buyer and Seller wish to obtain the consent of Grantor to the transfer of the Franchise and the System.

NOW, THEREFORE, BE IT HEREBY RESOLVED by Grantor that:

- 1. Grantor consents to the transfer of the Franchise and the System from Seller to Buyer, effective upon the closing of the transactions contemplated by the Agreement.
- 2. Grantor confirms that (a) the Franchise was properly granted; (b) there have been no amendments or modifications to the Franchise, except as set forth herein; (c) Seller is in compliance in all material respects with the provisions of the Franchise; (d) there are no defaults under the Franchise, or events which, with the giving of notice or passage of time or both, could constitute events of default thereunder; and (e) the Franchise remains in full force and effect in accordance with its terms.
- 3. Buyer acknowledges that it will not assign or transfer the Franchise to any person or entity without first notifying Grantor and obtaining the consent of Grantor, such consent not to be unreasonably withheld. For purposes of this paragraph, an "assignment" or "transfer" shall not be deemed to include the following types of transactions and activities:
 - (a) The assignment and transfer of the Franchise and/or the System to any person or entity which is affiliated with Buyer (an "Affiliate") by virtue of direct, indirect and/or common control, management or ownership;
