RESOLUTION NO. 97-____1

FOR THE CITY OF LEROY, ILLINOIS, A MUNICIPAL CORPORATION, PROVIDING FOR THE SALE OF REAL ESTATE OWNED BY THE CITY

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, owns real estate described as follows:

The East 21.5 feet of Lot 8, EXCEPT the North 8 feet and 3 inches thereof, in Block 129 in Wood and Conkling's Addition to the City of LeRoy, McLean County, Illinois, commonly known as 306 E. Center Street, LeRoy, Illinois (PIN (Book 15) 30-21-326-007);

and

WHEREAS, the corporate authorities of a municipality in the State of Illinois may, by resolution, authorize the sale or public auction of surplus public real estate, as provided under 65 ILCS 5/11-76-4.1 (1994 State Bar Edition (as amended)); and

WHEREAS, the Mayor and City Council of the City of LeRoy find that the real estate previously described herein is surplus public real estate as to the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1. The corporate authorities of the City of LeRoy, McLean County, Illinois, hereby find that real estate described as follows:

The East 21.5 feet of Lot 8, EXCEPT the North 8 feet and 3 inches thereof, in Block 129 in Wood and Conkling's Addition to the City of LeRoy, McLean County, Illinois, commonly known as 306 E. Center Street, LeRoy, Illinois (PIN (Book 15) 30-21-326-007).

is surplus public real estate, as provided under 65 ILCS 5/11-76-4.1, and should be sold.

Section 2. The value of the real estate has been determined by a written MAI Certified Appraisal or by a written certified appraisal of a State of Illinois certified or licensed real estate appraiser, a copy of which appraisal is available for public inspection at the office of the City Clerk of the City of LeRoy, during normal business hours.

<u>Section 3</u>. The City Attorney and other staff of the City of LeRoy are hereby directed to sell the afore-described real estate on those terms as are set forth hereafter in this resolution.

- Section 4. The size of the property previously described herein is 123.75 feet by 21.5 feet.
- <u>Section 5</u>. The use of the property is residential.
- <u>Section 6</u>. The zoning of the premises previously described herein is Commercial (C-1, Central Commercial Zoning District).

<u>Section 7</u>. The terms of sale are as follow:

- a. Any reasonable purchase price offered will be considered;
- b. The successful bidder, as a part of the sale terms, shall be required to enter into an installment sale contract for the sale of real estate providing for the demolition of the improvements and dead tree (at back, on or near west property line) currently on the subject property, such improvements to be removed, and the lot graded with fill and top soil as required by the city building code and in accordance with good land clearance practices and procedures, including removal of any underground utility lines that may reasonably be considered to otherwise present a hazard to the public should they not be removed, such work to be completed not later than July 31, 1997;
- c. A deed shall be executed by the City of LeRoy and placed in escrow pending the completion of the work as required by the aforesaid contract, said work to be inspected by the City Building Code Administrator and/or City Engineer, and to be considered completed upon the certification of such official(s) to the Mayor and City Council of the City of LeRoy, at which time the deed shall be removed from escrow and delivered to the successful bidder;
- d. All bids to be submitted in writing to the City Attorney, Hunt Henderson, 112 East Center Street, LeRoy, Illinois 61752, not later than 4:30 p.m., March 14, 1997;
- e. Bids shall be opened by the city attorney prior to the regular city council meeting to be held March 17, 1997, and such bids shall be presented to the city council for acceptance and approval, or rejection of any or all bids, as the case may be;
- f. The City reserves the right to reject all bids if the City Council finds no bid to be in the best interest of the municipality.
- Section 8. This Resolution shall be considered effective only upon its passage by a majority vote of at least two-thirds (2/3) of the corporate authorities holding office at the time this resolution is passed.
- <u>Section 9</u>. The City Clerk is directed, upon the adoption of this resolution, to publish a copy of this resolution at the first opportunity following its passage in the <u>LeRoy Journal</u>.
