A RESOLUTION PROVIDING FOR AND REQUIRING THE SUBMISSION OF THE PROPOSITION OF ISSUING \$950,000 OF SEWER SYSTEM IMPROVEMENT BONDS TO THE VOTERS OF THE CITY OF LOROY, MCLEAN COUNTY, ILLINOIS, AT THE NONPARTISAN ELECTION TO BE HELD ON NOVEMBER 7, 1995

WHEREAS, the City Council (the "Corporate Authorities") o.£ the City LeRoy, McLean County, of Illinois (the "Municipality"), has considered the existing sewer system facilities and the improvements and extensions necessary to be made in order that such facilities as improved and extended will more adequately serve the needs of the Municipality; and

WHEREAS, the Corporate Authorities hereby find and determine that it is necessary and in the best interests of the Municipality that the sewer system facilities of the Municipality be improved and extended by the acquisition, construction and installation of a Northeast relief sewer, sewer upsizing, East relief sewer, 54" sewer pipe near the library and High School, reshape waterway, North relief sewer, and West relief sewer, and related and incidental facilities, improvements and costs (the "Project"); and

WHEREAS, there are not sufficient funds on hand and available for the purpose of paying costs of the Project, and therefore, it will be necessary to borrow money and in evidence thereof issue the bonds of the Municipality to the amount of \$950,000 for payment of a part of the costs of the Project; and

WHEREAS, before the Municipality can provide for the

acquisition, installation and construction of the Project, and borrow money and issue bonds for such purpose, a proposition therefor must be submitted to the voters of the Municipality and be approved by a majority of the voters of the Municipality voting on such proposition at an election to be held in and for the Municipality, and it is deemed advisable, necessary and in the best interests of the Municipality that the proposition therefor be submitted to the voters of the Municipality at an election to be held and conducted in accordance with the general election laws:

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF LEROY, McLEAN COUNTY, ILLINOIS, as follows:

Section 1. Project Borrowing. That it is necessary and in the best interests of the Municipality that the Corporate Authorities be authorized to improve and extend the sewer system facilities of the Municipality by the acquisition, construction and installation of the Project, and that it is necessary and in the best interests of the Municipality that money be borrowed and in evidence thereof bonds of the Municipality be issued therefor in the amount of \$950,000 to pay a part of such costs.

Section 2. <u>Election</u>. That the proposition hereinabove referred to shall be submitted to the voters of the Municipality in accordance with the general election law at the nonpartisan election to be held on Tuesday, the 7th day of November, 1995, between the hours provided by law for voting on such day (the "Election").

Section 3. <u>Election Precincts</u>. That the Election shall be held in the voting precincts and at the polling places established by the County Board (the "County Board") of McLean County, Illinois (the "County"), for voters of the Municipality at the Election.

Section 4. Notice. That the County Clerk of the County (the "County Clerk") shall give notice of the Election in accordance with the general election law by publishing notice thereof once in one or more local, community newspapers published in and having general circulation in the Municipality, and also once in a newspaper published in the County and with general circulation in the Municipality, the dates of such publications of such notices to be not more than 30 nor less than 10 days prior to the date set for the Election. The ballot shall also be published as required by The Election Code.

Section 5. Newspaper. That it is hereby found and determined that The Pantagraph, Bloomington, Illinois, and the LeRoy Journal, LeRoy, Illinois, each is a local, community newspaper published in McLean County and having general circulation in the Municipality under Sections 12-4 and 12-5 of The Election Code of the State of Illinois, as amended (the "Election Code").

Section 6. Form of Notice. That the notice of the Election shall, subject to any modification necessary to comply with The Election Code, include the following:

NOTICE IS HEREBY GIVEN that at the nonpartisan election to be held on Tuesday, the 7th day of November, 1995, the following proposition will be submitted to the voters of the Municipality:

Shall the City of LeRoy, McLean County, Illinois, acquire, construct and install a a Northeast relief sewer, sewer upsizing, East relief sewer, 54" sewer pipe near the library and High School, reshape waterway, North relief sewer, and West relief sewer, related and incidental facilities, improvements and costs, and issue general obligation sewer system improvement bonds of the City to the amount of \$950,000 for such purposes and at an interest rate not to exceed the greater of 9% per annum or 120% of the "20-G.O. bond index"?
