RESOLUTION - 91-3

FOR LEVY OF SPECIAL REAL ESTATE PROPERTY TAXES

WHEREAS, the City Council of the City of LeRoy has adopted an appropriation ordinance for said City for the fiscal year beginning May 1, 1991, and ending April 30, 1992; and

WHEREAS, the City Council of the City of LeRoy has determined that the effects of inflation, rising prices and the general economic situation of the State of Illinois and of the nation have compelled an increase in appropriated funds in order to provide for municipal services and protection of the health, safety and general welfare of the citizens of the city; and

WHEREAS, the City Council of the City of LeRoy deems the present variety of municipal services and the quality and quantity of protection afforded the health, safety and general welfare of the citizens of the city to be not in excess of the minimum such services and protection necessary for the continued orderly development of the city and for the healthful inhabitation thereof by its citizens; and

WHEREAS, the anticipated revenues of the municipality are deemed to be less than the anticipated expenses of the City of LeRoy for the fiscal year beginning May 1, 1991, and ending April 30, 1992;

NOW, THEREFORE, be it resolved by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

FIRST - That the following special property taxes be levied for the purposes therein indicated:

- a. For the general maintenance, repair and building of city streets and bridges as provided by statute (c. 24, § 11-81-2, II. Rev. Stat., as amended);
- b. For the annual expense of the costs of protecting the City and its employees against liability, property damage loss, including all costs and reserves and being a member of an insurance pool, and to pay the cost of risk care management programs, in accordance with chapter 85, § 9-103, and § 9-107, II. Rev. Stat., as amended);
- c. For the expense of providing and maintaining police protection as provided by statute (c. 24, § 11-1-3; ..., II. Rev. Stat., as amended);
- d. For the City of LeRoy's annual contribution due for the Illinois Municipal Retirement Fund from time to time, as provided by statute (c. 108 1/2, § 7-171, II. Rev. Stat., as amended);

e. For the expense necessary to be met from time to time for the cost of participation in the Federal Social Security Insurance Program, and for the cost of participation in the Federal Medicare Program, as provided by statute (c. 108 1/2, § 21-110. and § 21-110.1, II. Rev. Stat., as amended).

SECOND - That said special taxes as previously enumerated be levied for the calendar year beginning January 1, 1991, and ending December 30, 1991, in such amounts as deemed necessary and appropriate by the City Council of the City of LeRoy.

THIRD - That said special taxes as previously enumerated be levied each and every year hereafter until action shall be taken by the City Council to discontinue the levy of all or any of said special taxes.
