RESOLUTION OF THE CITY OF LE ROY, McLEAN COUNTY, ILLINOIS SUPPORTING THE RAILBANKING OF NORFOLK SOUTHERN RIGHT-OF-WAY FROM MANSFIELD, ILLINOIS TO BLOOMINGTON, ILLINOIS

WHEREAS, indications are that Norfolk Southern Railroad will file for abandonment of the railroad right-of-way running from Mansfield, IL to Bloomington, IL in the year 2017; and

WHEREAS, Railbanking this railroad corridor would preserve greenways, allows for recreational/transportation uses, provides a utility corridor for local governments, and maintains the route for future use as a railway or innovative transportation systems; and

WHEREAS, the railbanking of this corridor has potential to promote tourism, stimulate economic development, provide alternative transportation options, support municipal services and improve the quality of life for communities along and near the corridor; and

WHEREAS, the railroad corridor is an asset to the central Illinois region, passing through 3 counties and five municipalities; now, therefore,

BE IT RESOLVED by the City of Le Roy as follows:

- 1) The City of Le Roy supports the efforts of the Illinois Department of Natural Resources to negotiate a rail-banking agreement with the Norfolk Southern Railroad for the right-of-way from Mansfield, IL to Bloomington, IL.
- 2) The City of Le Roy supports the Department of Natural Resources Trails Division serving as the overall negotiator and securing the interests of the Norfolk Southern Railroad right-of-way.
- 3) The City of Le Roy supports the Illinois Department of Natural Resources working jointly with local governments for future recreational trail development and public use of the corridor.
