AN ORDINANCE APPROVING A REDEVELOPMENT AGREEMENT WITH KENTUCKY FRIED CHICKEN OF KEWANEE FOR THE CITY OF LE ROY FIRST TAX INCREMENT FINANCING DISTRICT

WHEREAS, the Mayor and City Council of the City of Le Roy, Mc Lean County, Illinois, and Illinois municipal corporation, have determined that it is in the best interests of the city and its residents to enter into a REDEVELOPMENT AGREEMENT with Kentucky Fried Chicken of Kewanee Inc., for the redevelopment of real estate as described in Exhibit "A", attached hereto and incorporated herein; and
