#### ORDINANCE NO. 05-12-02-30

AN ORDINANCE APPROVING ASSIGNMENT OF A PARTY'S INTEREST IN A REDEVELOPMENT AGREEMENT BETWEEN THE CITY OF LE ROY, ILLINOIS, AND **PACIFIC INVESTORS, INC.**, FOR THE CITY OF LE ROY FIRST TAX INCREMENT FINANCING DISTRICT

WHEREAS, the Mayor and City Council of the City of Le Roy, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City of Le Roy and of its residents to approve the assignment of all the right, title and interest of **LE ROY TRAVEL MART**, under a Redevelopment Agreement with the City of Le Roy, for the City of Le Roy First Tax Increment Financing District; and

WHEREAS, PACIFIC INVESTORS, INC., has already made an assignment to anij alfa Inc., conditioned upon approval of the assignment by the City of Le Roy, and conditioned upon the City of Le Roy and PACIFIC INVESTORS, INC., agreeing upon certain cost eligible improvements made to the LE ROY TRAVEL MART of that business known as "LE ROY TRAVEL MART".

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. By "acceptance" of this ordinance and the agreement set forth herein, PACIFIC INVESTORS, INC., (hereinafter referred to as "LE ROY TRAVEL MART"), authorizes an acceptance document included as part of this ordinance, and the acceptance form signed by the appropriate officer(s) or agent(s) on behalf of PACIFIC INVESTORS, INC., shall be proof of the acceptance of this obligation by PACIFIC INVESTORS, INC.

Section 2. Approval is hereby given on behalf of the City of Le Roy for that assignment (a copy of said assignment being attached hereto as Exhibit A and incorporated herein by reference) of interest in the contract dated December 5, 2005, and entered into between the City of Le Roy and PACIFIC INVESTORS, INC., a copy of which is attached hereto as Exhibit B, which exhibit is incorporated herein by reference. By acceptance of this ordinance, anij alfa Inc. agrees that as a successor in interest to and assignee of LE ROY TRAVEL MART, Expressly assumes all the obligations of PACIFIC INVESTORS, INC., for the improvements under the agreement dated December 5, 2005, (Exhibit C) and agrees to be subject to all the conditions and restrictions to which Developer (PACIFIC INVESTORS, INC.) was subject under the aforesaid contract.

Section 3. If anij alfa Inc. agrees to the terms as previously set forth in this ordinance, it shall so indicate by having its appropriate officer(s) and/or agent(s) execute a copy of the "acceptance" as set forth in Exhibit C of this ordinance and shall submit the same not later than December 31, 2005, to the City Clerk of the City of Le Roy at which time the assignment shall be deemed approved and accepted by the City of Le Roy and the provisions of this ordinance shall be deemed binding upon anij alfa Inc..

Section 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
