## AN ORDINANCE AMENDING CHAPTER 8, REFUSE COLLECTION AND DISPOSAL, MUNICIPAL CODE OF LEROY, ILLINOIS, 1975 (AS AMENDED), BY AMENDMENT OF SECTION 8.06

WHEREAS. the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY," has previously by an ordinance provided for refuse collection and disposal and user charges for said collection and disposal; and,

**WHEREAS**, it is in the best interests of the City of LeRoy and its residents to amend said ordinance and provide for monthly billing of said user fees.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

**SECTION 1.** Section 8.06e. of Chapter 8, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby repealed.

**SECTION 2.** Section 8.06 of Chapter 8, Municipal Code of LeRoy, Illinois, 1975 (as amended), is hereby amended by inclusion of a new Section 8.06e in words and figures as follows:

e. Refuse Collection fees shall be included with the CITY water and sewer use bill to each water user monthly at the same time as the CITY water and sewer use bills are sent out. The City Clerk is hereby directed not to accept payment of water or sewer useportions of a monthly billing unless such payment is in the total amount billed (water, sewer and garbage collection), which shall include the appropriate refuse collection fees as herein provided. Owners or occupants of premises which do not use CITY water shall be billed monthly by separate billing for the appropriate refuse fee for their premises. A penalty of ten percent (10%) will be added to statements if not paid within fifteen (15) days after mailing. Non-payment of the bill may result in termination of refuse collection services upon the direction of the City Council.

SECTION 3. This ordinance shall be in full force and effect January 1, 1992, and after its passage and publication in pamphlet form as required by law.
