

ORDINANCE NO. 158

AN ORDINANCE AMENDING THE MUNICIPAL CODE, LE ROY, ILLINOIS, 1975, CHAPTER 3, CITY ADMINISTRATION, SECTION 3.05 "CITY CONTRACTS".

BE IT ORDAINED by the Mayor and the City Council of the City of Le Roy, Illinois:

Section 1. That Chapter 3, Section 3.05(a) is hereby amended by deleting the numbers "2500.00" in the first and fifth lines of said section as it was worded as a result of amendment of the original section by Ordinance No. 108, and in place of said deleted figures, the figures "4000.00" are added.

Section 2. That this Ordinance shall be in full force and effect from and after its passage and approval, as required by law, in pamphlet form as required by city ordinance.

PASSED by the Mayor and City Council of the City of Le Roy, Illinois, on the 1st day of February, 1982 and deposited and filed in the office of the City Clerk in said City on that date.
