ORDINANCE FOR THE ADDITION OF AN I-74 INTERCHANGE SERVICE ROAD TO LEROY'S CITY STREET SYSTEM

WHEREAS, the city of LeRoy, McLean County, Illinois, hereinafter called the CITY, and the state of Illinois, by and through its Department of Transportation, hereinafter called the STATE, did enter into an agreement for the improvement and jurisdictional transfer of the service road located in the southwest quadrant of the Interstate 74 and FAS Route 1478 (LeRoy Spur) interchange; consisting of and identified as Other Route 9 and SBI Route 119A Spur, State Section 57-23 and 102 respectively, also known as Hemlock Street.

NOW, THEREFORE, BE IT ORDAINED by the City Council of LeRoy, McLean County, Illinois, that effective 21 calendar days after the execution of the related city-state jurisdictional transfer agreement, the CITY agrees to assume jurisdiction of the following portions of highways:

- a. Other Route 9 (Hemlock Street) - From the west edge of pavement of FAS Route 1478 (LeRoy Spur) and extending ±0.18 kilometers (±0.11 mile) to the northwest and north.
- b. SBI Route 119A Spur No. 24.88 (Hemlock Street) - From the north end of Other Route 9 (located 0.11 mile/0.18 km northwest and north of FAS 1478/LeRoy Spur) extending northerly ±0.16 km (0.10 mile) to Empire Township Road 517 (N400 Road) located at the city of LeRoy's west corporate limits.

This ordinance shall be in full force and effect from and after its passage, approval, and publication.




