## ORDINANCE NO. 766

## AN ORDINANCE PROVIDING FOR ACCEPTANCE OF JURISDICTION AND ADDITION OF A PORTION OF FAS ROUTE 1478 (LE ROY SPUR/CHESTNUT STREET) TO LE ROY CITY STREET SYSTEM

WHEREAS, the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, hereinafter called the "CITY," and the State of Illinois, by and through its Department of Transportation, hereinafter called the "STATE," have entered into an agreement for the improvement and jurisdictional transfer of a portion of FAS Route 1478, also known as the LeRoy Spur and Chestnut Street. With the use of STATE and local funds, improvements include reconstruction and resurfacing of FAS Rouse 1478/Chestnut Street from 860' north to 1,520' south of Maple Street, including improvements to the intersection at Maple Street,


NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

Section 1: On May 1, 1998, the CITY agrees to assume jurisdiction of, and add to the LeRoy city street system, FAS Route 1478 (LeRoy Spur/Chestnut Street), beginning at the south edge of the pavement of U.S. Route 150 (Cedar Street) and extending southerly and southwesterly 9.83 kilometers (0.52 mile) to the north abutment of the Interstate 74 overhead structure (see attached Addendum #1). The said transfer does not include the interstate overhead structure itself (Structure No. 057-0132).

Section 2: The City Clerk of the City of LeRoy is directed to forward three certified copies of this Ordinance to the State of Illinois Department of Transportation, through its District Engineer's office at Ottawa, Illinois.

Section 3: This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law, and be effective pursuant to law.
