

ORDINANCE NO. 16-07-02-50

AN ORDINANCE AMENDING THE
KIND, AND CLASSIFICATION OF LOCAL LIQUOR LICENSES

WHEREAS, the City of Le Roy is an Illinois municipal corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and

WHEREAS, Article IV of the Illinois Liquor Control Act of 1934, 235 ILCS 5/4-1, et seq., authorizes the corporate authorities of the City to license and regulate the sale of alcoholic liquor within the City, and to determine the number, kind and classification of local liquor licenses, as well as the fees for such licenses and to provide such further regulations and restrictions on the issuance and operations pursuant to such local licenses; and

WHEREAS, the City has established the kind, and classification of local liquor licenses (Code § 3-3-11), and desires to establish an additional classification for the retail sale of beer manufactured on the premises in its original package for consumption off the premises, and the sale of beer and wine for consumption on the premises; and

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:

Section 1. Recitals. The Council hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true, and correct and does incorporate them into this Ordinance by this reference.

Section 2. Amendment to Section 3-3-11. Section 3-3-11 of the City of Le Roy Code of Ordinances, entitled "Classification of Licenses; Fees; Restrictions on Licenses," is hereby amended to add a new subsection (G), which shall read as follows:

G. Class E Licenses.

1. Class E licenses shall authorize the retail sale of beer manufactured on the premises in its original package for consumption off the premises; and the sale of beer and wine for consumption on the premises. The licensee shall:
 - a. maintain accurate records as to the total gallons of beer manufactured on the premises and sold for consumption off premises, and provide such records to the local liquor control commissioner upon request;
 - b. segregate the portion of the licensed premises dedicated to the manufacturing of beer from the remainder of the premises, restricting public access to the manufacturing area except during supervised tours; and

- c. comply with all applicable federal, state, and local laws and regulations, including, but not limited to, payment of applicable taxes, procurement of any required federal brewer's notice, Illinois manufacturer's liquor license, Illinois craft brewer's license, and all other required licenses and permits concerning manufacture, packaging, storing, sale, and distribution of alcoholic beverages.

2. The annual fee for such license shall be \$1,750.00.

Section 4. Conflict. All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section 5. Effective Date. This Ordinance shall be in full force and effect following its passage and approval as required by law.






