ORDINANCE NO. 10-02-03-80

AN ORDINANCE AMENDING TITLE 7, PUBLIC WAYS & PROPERTY; CHAPTER 4, PARKS AND RECREATION AREAS; SECTION 2, QUIET HOURS OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003 (AS AMENDED)

WHEREAS, the City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY" has determined that it is necessary and in the best interests of the CITY and its residents, that the quiet hours for city parks be amended.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

Section 1. Title 7, of the Municipal Code of Le Roy, 2003 (as amended), Chapter 4, Section 2 is hereby repealed.

Section 2. Title 7, of the Municipal Code of Le Roy 2003 (as amended), Chapter 4, Section 2 is hereby added.

All persons in any park or recreation area owned or administered by the city shall observe "quiet hours" in such park or recreation area from ten o'clock (10:00) P.M. on any day until six o'clock (6:00) A.M. the next morning, daily. "Quiet" is hereby defined to mean tranquil and free from interference, noise or other disturbance. "Quiet hours" shall denote a period of calmness, stillness, inactivity, and freedom from noise.

Section 3. This ordinance shall be in full force and effect from and after its passage, adoption and publication in pamphlet form as required by law.
