AN ORDINANCE FURTHER AMENDING ORDINANCE NO.669- SALARY SCHEDULE ORDINANCE

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is appropriate and in the best interest of the City to further amend Ordinance No. 589 - Salary Schedule Ordinance, adopted by the City Council on _______, 1996; and

WHEREAS, the Mayor and City Council of the City of LeRoy find it is necessary to make temporary adjustments to the salary ordinance in order to alleviate a manpower shortage in the City of LeRoy Police Department,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

Section 1. Section 2. Salary and Pay Schedule for Appointed Officers and Employees (of the City of LeRoy) of Ordinance No. 669, "Animal Control Officer (contract service)" is hereby deleted and a new Section 2. Salary and Pay Schedule for Appointed Officers and Employees (of the City of LeRoy) of Ordinance No.669, "Animal Control Officer (contract service)" is added by addition of the following words and figures as follows:

Animal Control Officer (contract service) \$300.00 per month

(This position can be broken down and assigned to "First" Animal Control Officer and a "Second" Animal Control Officer, in which case the First Animal Control Officer will be paid \$150.00 per month and his or her primary responsibility shall be to handle dog control. The Second Animal Control Officer shall be paid \$150,00 per month and his or her primary responsibility shall be to handle cat control. Whether the position remains at one Animal Control Officer, or is divided between the First and Second Animal Control Officers, the position would be considered a contract position to be filled by one or two independent contractors.)

Section 2. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
