AN ORDINANCE AMENDING CHAPTER 12, NUISANCES, MUNICIPAL CODE OF LEROY, ILLINOIS 1975 (AS AMENDED)

WHEREAS the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents, in administering and enforcing the ordinances of the City, that the waiting period for removal of abandoned vehicles be reduced from its current period to a shorter length of time,

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1. That Chapter 12, Nuisances, Section 12.06(d), Municipal Code of LeRoy, Illinois 1975 (as amended), is hereby amended as follows:

Said amendment being deletion of the word "sixty" and the number (60) appearing in the 7th line of said subsection after the words "longer than" and before the word "days"; deletion of the word "sixty" in the 8th line of said subsection after the word "than"; and deletion of the number (60) at the beginning of the 9th line of said subsection before the word "days" and substitution for said words and numbers deleted of the word "seven" in place of the word "sixty" wherever the same may have appeared in the aforesaid subsection d and substitution of the number "7" in place of the number "60" wherever the same shall have appeared in said subsection.

Section 2. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
