ORDINANCE NO. 01-08-01-70

AN ORDINANCE TO REPEAL ORDINANCE NO. 565 (ADOPTING A CODE OF ETHICS, PROFESSIONAL STANDARDS OF DUTY PERFORMANCE, AND RULES AND REGULATIONS, FOR THE LE ROY POLICE DEPARTMENT)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the City and its residents, for the public health, safety, and wealfare, and for the efficient administration of the city government and, in particular, the administration of the police department of the City, to discontinue the use of the code of ethics, professional standards of duty performance, and rules and regulations, all for the LeRoy Police Department, as previously adopted for the use, adminsitration, and regulation of the Police Department of the City of LeRoy, in accordance with ordinance no. 565, adopted November 7, 1994; and

WHEREAS, the Mayor and City Council of the City of LeRoy have determined that for the best interests of the City and the administration of its Police Department new regulations are appropriate to be adopted by direction of the police chief of the City of LeRoy,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, in lawful meeting assembled, as follows:

Section 1: Ordinance No. 565, adopted November 7, 1994, is hereby repealed effective July 1, 2001, in its entirety.

Section 2: This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
