AN ORDINANCE AMENDING TITLE 8; CHAPTER 5 OF THE MUNICIPAL CODE OF LE ROY, ILLINOIS, 2003, SEWER SERVICE FEES AND CHARGES

WHEREAS, the Mayor and City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, have reviewed the fees for Sewer Service Fees and Charges; and

WHEREAS, the Mayor and City Council of the City of Le Roy have determined that said fees shall be increased, being in the best interest of the city and its residents; and

WHEREAS, all things required by law an ordinance to be done in regard to increasing said fees has been completed;

NOW, THEREFORE BE IT ORDAINED, by the City Council of the City of Le Roy, Illinois in lawful meeting assembled, as follows:

SECTION 1. Title 8, Chapter 5, Section 1B, Sewer Service Fees and Charges, of the Municipal Code of Le Roy, Illinois 2003 is hereby amended by substitution of the figure "\$500.00" in place of "\$200.00."

SECTION 2. Title 8, Chapter 5, Section 1B, Sewer Service Fees and Charges, of the Municipal Code of Le Roy, Illinois 2003 is hereby amended by substitution of the figure "\$1,000.00" in place of "\$300.00."

SECTION 3. Title 8, Chapter 5, Section 1B, Sewer Service Fees and Charges, of the Municipal Code of Le Roy, Illinois 2003 is hereby amended by substitution of the figure "\$2,500.00" in place of "\$500.00."

SECTION 4. Title 8, Chapter 5, Section 1B, Sewer Service Fees and Charges, of the Municipal Code of Le Roy, Illinois 2003 is hereby amended by the addition of:

A \$50.00 inspection fee will be assessed for each required inspection.

SECTION 5. This ordinance shall be in full force and effect from and after its passage and approval as required by law.
