ORDINANCE NO. 08-02-01-41

AN ORDINANCE AMENDING TITLE 8, WATER & SEWER; CHAPTER 5, SEWER SERVICE FEES AND CHARGES; SECTION 2, SEWER SERVICE RATES AND CHARGES, SUBSECTION D, RATES AND CHARGES ESTABLISHED OF THE MUNICIPAL CODE OF LEROY, ILLINOIS, 2003 (AS AMENDED)

WHEREAS, the City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY" has determined that it is necessary and in the best interests of the CITY and its residents, that the basic user rates for sewage disposal services be increased.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

- Section 1. Title 8 of the Municipal Code of Le Roy, 2003 (as amended), Chapter 5, Section 2, Subsection D 1 a, b, and c are hereby repealed.
- Section 2. Title 8 of the Municipal Code of Le Roy, 2003 (as amended), Chapter 5, Section 2, Subsection D 1 is hereby amended in words and figures as follows:

Basic user rate: There shall be and there is hereby established a minimum charge and basic user rate for the use of and for service supplied by the wastewater facilities of the CITY. There shall be a minimum charge of \$5.00 per one month period to all users whose water consumption does not exceed 1000 gallons per month period. There shall be a basic user rate of \$5.00 per 1000 gallons metered or adjusted (as set forth in Title 8, Chapter 5, Section 2) in excess of 1000 gallons per one month period to all users who discharge normal strength wastes to the system effective with the first water meter reading after February 1, 2008.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
