ORDINANCE NO. 17-02-01-41

AN ORDINANCE AMENDING THE CITY CODE PROVISIONS RELATING TO SEWER USER FEES

WHEREAS, the City of Le Roy is an Illinois municipal corporation operating in accordance with the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and

WHEREAS, the City operates a water and sewer system that is funded, in part, through water and sewer user fees; and

WHEREAS, the City recently completed installation of improvements to its sewer system to separate the existing sewer system as mandated by the IEPA, and desires to reduce the long-term control plan service fee to reflect the completion of these improvements and to meet certain IEPA-mandated post-monitoring program obligations; and

WHEREAS, in 2016, the City issued bonds for various capital improvement projects to the City's water and sewer systems, which bonds require the imposition of an additional user fee to pay the debt service on these financial obligations; and

WHEREAS, in furtherance of these projects, the City desires to amend the City Code provisions relating to sewer user fees as set forth in this Ordinance (a separate ordinance will impose similar water user fees).

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Le Roy, McLean County, Illinois, as follows:

Section 1. Recitals. The above-referenced recitals are hereby incorporated into this Ordinance by this reference.

Section 2. <u>Amendment to Section 8-5-10.</u> Section 8-5-10 of the City of Le Roy Code of Ordinances, titled "Long Term Control Plan Service Fee," is hereby amended as follows:

8-5-10: LONG TERM CONTROL PLAN SERVICE FEE:

- A. Combined Sewer Separation Requirements: The anticipated expense to separate the existing sewer system will include the following Illinois environmental protection agency mandates:
 - 1. Separation of the existing combined sewer system by December 31, 2018. The total estimated cost to complete this project is two million dollars (\$2,000,000.00).
 - 2. Implementation of a post-monitoring process upon completion of the separation project referenced above.
- B. Fee: All utility customers of the city of LeRoy will be required to pay a three dollar (\$3.00) per month fee to fund the post-monitoring process mandated by the IEPA. All utility customers of the city of LeRoy

will be required to pay a thirteen dollar (\$13.00) per month fee. This fee will begin on the first bill prepared after April 1, 2011, and will continue for no longer than one hundred forty four (144) consecutive months (12 years) or upon repayment of all debt in relation to said project, whichever occurs first.

Section 3. <u>Amendment to Chapter 5, Title 8.</u> Chapter 5, titled "Sewer Service Fees and Charges" of Title 8, titled "Water and Sewer," is hereby amended to add a new Section 8-5-11 of the City of Le Roy Code of Ordinances, as follows:

8-5-11: SEWER CAPITAL BOND PROJECT FEE:

All utility customers of the city of LeRoy will be required to pay a five dollar (\$5.00) per month fee to finance capital projects relating to the sewer system, including payment of the debt service on the capital bonds issued in 2016.

Section 4. Conflict. All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

Section 5. Effective Date. This Ordinance shall be in full force and effect following its passage and approval as required by law.
