ORDINANCE NO. 05-05-01-41

AN ORDINANCE ADOPTING REGULATIONS OF THE COMBINED SEWER OVERFLOW (CSO) OF THE MUNICIPAL CODE, CITY OF LE ROY, ILLINOIS 2003 (AS AMENDED), TITLE 8, WATER & SEWER, CHAPTER 4, SEWER USE AND SERVICE, SECTION 5, BUILDING SEWERS AND CONNECTIONS, SUBSECTION I, DISCHARGED INTO SYSTEM

WHEREAS, the City Council of the City of Le Roy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "City" has determined that it is necessary and in the best interest of the CITY and its residents, that new regulations for combined sewer overflow be added.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of Le Roy, in lawful meeting assembled, as follows:

Section 1. Chapter 4, Municipal Code of Le Roy, 2003 (as amended), Section 5, Subsection I is hereby amended in words and figures by adding the following.

Paragraph 3: (8-4-5-I-3)

Any inflow sources, i.e., foundation drains, downspouts or other such sources which are connected to a combined sewer shall be disconnected from said combined sewer and connected to a separate storm sewer at such time as said storm sewer is made available to the property with the inflow source connection. The disconnection of the inflow source(s) shall be made within one hundred eighty (180) days after the issuance date of said notice from the City to property owner to make said disconnection. "Made available" shall be defined as a condition in which a separate storm sewer has been installed and made operational within a City right-of-way that is contiguous with said property.

Section 2. Chapter 4, Municipal Code of Le Roy, 2003 (as amended), Section 5, Subsection I is hereby amended in words and figures by adding the following:

Paragraph 4: (8-4-5-I-4)

The domestic waste connection, for all new buildings and when connected to a combined sewer, shall be constructed to handle only domestic waste from the building. All inflow sources, i.e., foundation drains, downspouts, or other such sources, shall be connected to a separate inflow connection. At such time as a separate storm sewer is made available to the property, the property owner shall disconnect the inflow connection from the combined sewer and connect it to the separate storm sewer, entirely at the expense of the property owner.
