**ORDINANCE NO. 14-01-01-90**

**AN ORDINANCE AUTHORIZING EXECUTION OF THE ILLINOIS  
PUBLIC WORKS MUTUAL AID NETWORK AGREEMENT  
(IPWMAN)**

**WHEREAS**, the Constitution of the State of Illinois, 1970, Article VII, Section 10, authorizes units of local government to contract or otherwise associate among themselves in any manner not prohibited by law or ordinance; and,

**WHEREAS**, the “**Intergovernmental Cooperation Act**” 5ILCS 220/1 et seq., provides that any power or powers, privileges or authority exercised by a unit of local government may be exercised and enjoyed jointly with any other local unit of government; and,

**WHEREAS**, Section 5 of the “**Intergovernmental Cooperation Act**” 5 ILCS 220/5, provides that any one or more public agencies to perform any government service, activity or undertaking which any of the public agencies entering into the Contract is authorized by law to perform, provided that such Contract shall be authorized by the governing body of each party to the Contract, and,

**WHEREAS**, THE Mayor and the City Council of the City of Le Roy have determined that it is in the best interest of the City of Le Roy and its residents to enter into an intergovernmental agreement to secure each the benefits of mutual aid in public works and the protection of life and property from an emergency or disaster and to provide for public works assistance, training and other necessary functions to further the response and recovery from any emergency or disaster. The principle objective of the public works mutual aid assistance being the response to and recovery from any emergency or disaster and the return of the community to as near normal as quickly as possible.

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Le Roy, Illinois, in lawful meeting assembled, as follows:

**SECTION ONE:** That the Mayor and the City Council be and are hereby authorized to execute an Agreement for participation in the **Illinois Public Works Mutual Aid Network (IPWMAN)**, a copy of said Agreement being attached hereto and being made a part hereof.

**SECTION 2.** This ordinance shall be in full force and effect from and after its passage and approval as required by law.
