ORDINANCE NO. 786

AN ORDINANCE AMENDING CHAPTER 4-STREETS, DITCHES AND TREES,  
MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS 1975 (as amended)  
BY AMENDMENT OF SECTION 4.30-DRIVEWAY PERMITS,  
AND AMENDMENT OF ORDINANCE NO. 482

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is appropriate, in order to provide for the improvement of the public's health, safety and welfare, that Ordinance No. 482 and Section 4.30 of Chapter 4 of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended) be amended,

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled as follows:

Section 1: Section 4.30-Driveway Permit, (a), of Chapter 4, "Streets, Ditches and Trees," Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended by substitution of the words "Building Administrator, head of the Street Department" in place of the words "Director of Public Works" in said sub-section.

Section 2: This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as required by law.
