ORDINANCE NO. 841

AN ORDINANCE AMENDING CHAPTER 4 STREETS, OF THE MUNICIPAL CODE OF THE CITY OF LE ROY, ILLINOIS, 1975 (as amended), BY ADDITION OF NEW SECTION 4.04-1/2 LOCATION OF DITCHES, DRAINS, POLES, WIRES, ETC., IN MUNICIPAL RIGHT-OF-WAY WITHOUT CONSENT.

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, hereinafter referred to as "CITY", have determined that it is in the best interest of the CITY and of its residents that Chapter 4 STREETS, of the Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), be hereby amended to provide for the regulation of the placement of ditches, drains, poles, wires, and other equipment and appurtenances under or along any street or highway in the CITY without the written consent of the appropriate officer on behalf of the CITY; and

WHEREAS, the corporate authorities of municipalities in the State of Illinois may regulate the use of streets and other municipal property within the limits of their municipality, as provided in accordance with 65 ILCS 5/11-80-2 (as amended),

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of LeRoy, Illinois, in lawful meeting assembled, as follows:

<u>Section 1</u>. Chapter 4 STREETS, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby amended by addition of new Section 4.04-1/2, in words and figures as follows:

4.04-1/2 LOCATION OF DITCHES, DRAINS, POLES, WIRES, ETC., IN MUNICIPAL RIGHT-OF-WAY WITHOUT PERMISSION. No ditches, drains, track, rails, poles, wires, pipeline or other equipment of any public utility company, municipal corporation, or other public or private corporation, association, or person shall be located, placed or constructed upon, under or along any highway or street in the City of LeRoy without first obtaining the written consent of the Superintendent of Streets for the City of LeRoy, or other appropriate official designated from time to time by the Mayor and City Council.

<u>Section 2</u>. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
