## ORDINANCE NO. 783

AN ORDINANCE AMENDING ORDINANCE NO. 558, CHAPTER 41, TRAFFIC SECTION 41.40- SECTION 2(e), SCHEDULE E II-YIELD SIGNS, TWO-WAY YIELD, AND SECTION 41.40 - SECTION 2(e), SCHEDULE E I(d) TWO-WAY STOPS, OF THE MUNICIPAL CODE OF THE CITY OF LEROY, ILLINOIS 1975 (as amended)

WHEREAS, the Mayor and City Council of the City of LeRoy, McLean County, Illinois, an Illinois municipal corporation, have determined that it is in the best interests of the residents of the City of LeRoy that Chapter 41, Traffic, Municipal Code of LeRoy, Illinois, 1975 (as amended), be amended to provide for the amendment of yield controlled street intersections.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of LeRoy, McLean County, Illinois, in lawful meeting assembled, as follows:

- <u>Section 1</u>: Section 41.40 of Chapter 41, Traffic, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), Schedule E, II YIELD SIGNS, TWO-WAY YIELD:
- (19) East Elm Street at North Barnett Street-yield signs are on East Elm Street-North Barnett is the thru-street.

  by repealing (19).
- Section 2(a) of Section 41.40 of Chapter 41, Traffic, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), by addition of a new item to Schedule E, I. STOP SIGNS, (d) TWO-WAY STOPS, as follows:
- (85) East Elm Street at North Barnett Street stop signs are on East Elm Street/North Barnett Street is the thru-street.
- Section 3. Section 41.40 of Chapter 41, Traffic, Municipal Code of the City of LeRoy, Illinois, 1975 (as amended), is hereby further amended by addition of new Schedule E the same as attached hereto as Exhibit A, which is incorporated herein by reference.

Section 4. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as required by law.
